## "All Saints' Day & All Souls' Day"

Greetings my brother Knights and families! A belated "Happy Columbus Day" and "Happy Indigenous People's Day!" Yes, we absolutely need to recognize Christopher Columbus for his accomplishment of sailing across the Atlantic Ocean and "discovering" North America" for Spain. But at the same time, we need to recognize the people who were already inhabiting North America for some 23,000 years before Columbus, the Native Americans!

With the end of October approaching quickly, let's examine the upcoming special days that we will experience. October 31<sup>st</sup>. is "All Hallows Eve" a.k.a. "Halloween" and at one time, Catholic Christians would hold a vigil when the faithful would pray and fast prior to the feast of "All Hallows Day" a.k.a. "All Saints' Day."

"All Saints' Day" recognizes the people who are known only to God as saints and the people canonized by the Church. Because of that, "All Saints' Day" celebrates all faithful followers of Jesus Christ throughout all of Church history. It's a feast day remembering those who have gone before us, honoring their lives and faithfulness. Believers come together to celebrate continued communion with saints through the ages, recognizing their continued participation in the body of Jesus Christ.

Surely you know "All Saints' Day" is a Holy Day of Obligation, unless it falls on a Saturday or a Monday, then Mass attendance is not required. Did you know that "All Saints' Day" was declared a feast day on May 13, 609 by Pope Boniface IV? On that day in Rome, Pope Boniface consecrated the Pantheon to the Virgin Mary and all martyrs. Pope Gregory III made the official date on November 1<sup>st</sup>. during his reign, between 731-741AD. At this time, he dedicated a chapel in St. Peter's Basilica giving honor to "all saints." Then 100 hundred years later, Pope Gregory IV made November <sup>[st</sup>. an official Holy Day for the entire Church.

A prayer for "All Saints' Day" is: "Almighty God, you have knit together your elect in one communion and fellowship in the mystical Body of your Son. Give us grace so to follow your blessed saints in all virtuous and godly living, that we may come to be like those who truly love you; through Jesus Christ Our Lord, who with you and the Holy Spirit lives and reigns, one God, in glory everlasting. Amen."

"All Souls' Day" is observed on November  $2^{d}$ . and is dedicated to those who have died and have not made it to heaven yet. On "All Souls' Day," Catholics celebrate a commemoration of All the Faithful Departed, a.k.a. the Day of the Dead. Go to Mass if possible and spend time in prayer for the souls of our loved ones, as well as those who have no one to pray for them.

It is an honored custom, as well, to visit the graves of our deceased family and friends and pray for them, as they are probably in Purgatory. The Legion of Mary Praesidium (of which I have been designated as it's Spiritual Director) from my church at St. Ann in Florence, 'Mary, Mother of Christians', has targeted all Tuesdays in the month of November, to go out to 5 different cemeteries and spend at least an hour praying the Rosary and other prayers for the souls of the departed friends and families that are buried in these 5 cemeteries. We did it last year, and it was very meaningful and spiritual. You cannot pray too much for the souls in Purgatory! Amen!

these. They appear to be everywhere: television advertisements, billboards, signs outside of business, etc. We cannot escape it. Many of the businesses in our towns and communities need help. And the Knights of Columbus in South Carolina is no exception.

Believe it or not, our State Convention is only a short six months away. That means that we will soon be selecting the Officers that will lead us in the 2023-2024 fraternal year. It may appear so because, more times than not, they are the only candidate for the position. Additionally, you do not have to have District Deputy or Grand Knight experience to apply. I know there are many "leaders" out there who could be very successful in helping to lead the state in the years to come.

Are you one of those leaders? If so, I invite you to submit your resumé to our Nominating Committee Chairman, Daniel E. Barton, IPSD & District Master at dbarton4221@ gmail.com. All resumés must be received no later than midnight on January 13, 2023. Interviews will be conducted on Friday, February 3,2023 at the Best Western Plus on Two Notch Rd. in Columbia. The Nominating Committee will select and nominate the best gualified candidate for each officer position and nominate delegates to the Supreme Convention and present the list of candidates at the Grand Knight Midyear meeting on February 4, 2023. I can tell you from personal experience, serving as a State Officer is a very rewarding experience and one that should

not be taken lightly. Before submitting your resumé, please review the State Officers Duties and Responsibilities listed under the "Resources" tab at kofcsc.org. Being a state officer is a commitment to the 10,000 plus members in the state as well as to your fellow state officers. Please talk it over with your spouse and family to make sure they are all on board.

Change of Subject. In last month's article, I listed the 14 councils that earned the Star Council Award for last fraternal year. I am pleased to report that a 15th council has been added to the original list. Congratulations to Council 5026 in Beaufort. Please join me in also congratulating Council 9576 in Pickens for being the first in the state to reach their 2022-2023 membership goal and Council 17760 in Charleston to be the second to do so. Additionally, councils 5194 in Florence and 16903 in Chapin are only one member away. I would like to personally thank all the Grand Knights and council Membership Directors and all those who are offering the opportunity of KofC membership to those men around them. During the first quarter of this fraternal year, we added 142 new members to our roles. As we continue to grow the order, we will be able to do even more for our parishes and communities and keep the dream of Blessed Father Michael McGivney alive and well in the great state of South Carolina.

The readings for the 28<sup>th</sup> Sunday in Ordinary Time are profound. In the first reading, we hear about Naaman who was a commander of the army of Syria and who suffered from leprosy. Like Naaman, we all have accomplished and achieved many things in our lives. However, we all suffer from one ailnment or another, be it physical, mental, or emotional. And like Naaman, it is through our weakness or frailty that we find God in our times of need.

In the Gospel, St Luke tells us that 10 lepers met Jesus as he traveled through Samaria and Galilee. Jesus commanded that they "go show yourselves to the priests" and that while on the way they were healed. Only one, the Samaritan, returned to give thanks and glorify God. Jesus said to him "stand up and go; your faith has saved you".

Worthy Grand Knights, Faithful Navigators and Members of the State Council:

Marks of Respect for the Flag of the United States

• The National Flag should be flown daily from sunrise to sunset in good weather from public buildings, schools, permanent staffs in the open and near polling places on election days. The flag should not be displayed on days when the weather is inclement, except when an all-weather flag is displayed. The flag may be displayed twenty-four hours a day if properly illuminated during the hours of darkness.

## Bishop England Council #724 – Serving Catholics who are Serving Our Country


Chaplain Fr. Thomas Kelly, Captain, U.S. Army, called on Bishop England Council #724's Ft. Jackson Roundtable to serve nearly 500 Catholic U.S. Army Basic Trainees attending Mass at Ft. Jackson's Solomon Center.

The Knights responded by organizing the effort, cooking and serving over 500 hotdogs after stuffing them in buns and bagging them individually. The soldiers were all smiles as they ate "the best food they'd had in weeks!".

- The flag should always be flown on national and state holidays and on those occasions proclaimed by the President. On Memorial Day, the Ensign shall be half staffed until noon.
- The flag should be hoisted briskly and lowered ceremoniously. It should never be dipped to any person or thing nor should it ever be displayed with the union down except as a signal of dire distress.
- The flag should never be allowed to touch anything beneath it, nor should it ever be carried flat or horizontally –always aloft and free.
- It should never be used as drapery or decoration, for carrying or holding anything, or stored in such a manner that it will be damaged or soiled.
- The flag should never be used for advertising purposes in any manner whatsoever, nor should any picture, drawing, insignia or other decoration be placed upon or attached to the flag, its staff or halyard. The flag should not be embroidered on personal items nor printed on anything designed for temporary use and then discarded.
- When the flag is so worn or soiled that it is no longer suitable for display, it should be destroyed in a dignified manner, preferably by burning.
- For rules on Posting the Colors, please refer to the Patriotic Degree ceremonial book.





