

My Brother Knights,

As I began to put notes together for this month's article I concentrated on our Gospel from this morning and to the wonderful homily shared by our pastor at Shaw Air Force Base, Father Joseph. The gospel was Matthew's ac-

count of the Transfiguration which all of us have heard many times. Two particular lines in the gospel resonated with me: *...Lord it is good that we are here.* (Mat 17:4) and *"This is my beloved Son in whom I am well pleased; <u>listen</u> to <u>Him</u>" (Mat 17:5)*

It truly is good to be here; to be a member of the greatest fraternal and family-oriented organization in the world; to be here with Brothers who are willing to share their Catholic Faith with those around them; and, to experience the genuine love, generosity, and concern for those less fortunate than themselves.

It's somewhat ironic, but just a couple days before the Transfiguration Gospel was read, I was at our local car dealership having my vehicle serviced. While waiting, I was talking to a friend of mine who is also one of the salesmen there. He is very active in his church, and in fact serves in a role which sounds somewhat similar to our District Deputy, in that it requires him to travel through his district (which is comprised of a much bigger area than our districts) to talk at the various churches in his assigned area. He mentioned that he would soon be traveling to Chicago to attend national meetings. As we talked, we agreed that, despite the travel and occasional challenges, we enjoyed what we were doing and believed that God puts everyone where they need to be.

I firmly believe that God has put each one of us in a particular place, at a particular time, for a particular purpose. So why are we here and what is our purpose? This is where we have to refer to the second line mentioned above, ... *listen to him.* As Father Joseph pointed out, this involves active listening rather than just hearing the words. Lent provides us great opportunities to really concentrate on listening to what the Lord is asking of us. Daily Mass, Eucharistic Adoration, and Stations of the Cross are just a few examples of how we can draw closer to God and really discover (or rediscover) our mission.

My prayer this Lent is that each one of us will find that place where we're supposed to be and doing what God is asking of us and that our prayers, fasting, and almsgiving will bring us closer to our Lord and each other. Vivat Jesu!

"Whatsoever you do to the least of my brothers, this you do unto me"-Jesus Christ

All people with intellectual and/or developmental disabilities (IDD) have the right to full lives in communities of their choosing where they can live, learn, work, and enjoy life. To achieve this, people with IDD need access to comprehensive, person-centered, and self-directed high quality long term supports and services (LTSS). Robust, reliable, and immediately accessible funding sources that include Medicaid alone has proved to be insufficient. There must be public support that emphasizes self-direction, is well-funded, responsive, flexible enough to meet the needs, and is developed with—and not for—people with IDD. Waiting lists for home and community-based supports and services are unacceptable and must be eliminated.

The Issues:

There are a variety of barriers to ensuring that people with IDD receive the LTSS required to live their fullest life in communities of their choice. These include but are not limited to:

Insufficient Medicaid funding. Institutional bias in the Medicaid program. Continued and worsening crisis of unmet need. Persistent and worsening workforce crisis.

We will be going into these topics in more detail in the coming months, however, the bottom line for the Knights of Columbus is this, our disabled citizens need our help more than ever in the 141 years since Fr. McGivney founded our order! Every council is in the closing months of their Columbus Hope Drive and will be starting up a new season in July. The Drive kickoff will be July 8, 2023, at St. John Neumann's Gym in Northeast Columbia. We'll have more details and times coming soon. Please do all you can to support the "Least of Jesus' brothers."

From the State Protocol Chairman

PROTOCOL

Worthy Grand Knights, Faithful Navigators and Members of the State Council:

Correspondence

With Council and Assembly installations coming up the following is provided as guidance for you to follow.

When corresponding with others, email id the most effective and efficient means of communication. However, e-mail may not be the most appropriate means of communication in all circumstances. Sometimes typed memos or letters, on letterhead, should be utilized and care should be taken to ensure that the letter writer uses proper letter writing techniques.

E-mails also need to be handled with care. Officers need to make certain that their e-mail address is appropriate along with the content contained within the e-mail. Sending an e-mail does not ensure delivery to the intended recipient. E-mail is cost effective and can be an easy way for councils or assemblies to communicate, but it is not a guarantee of participation at an event. E-mail, as with letters, need to be clearly stated and have the main points separated. Make certain that e-mails that contain confidential information are not broadcast to a large group. E-mails cannot replace the personal contact of a phone call or personal conversation.

Modern means of social communications provide members of the Knights of Columbus with powerful tools that can build up your council by promoting its charitable mission and by encouraging members to live out their Catholic faith. The term "social communications" refers to, among other things, the internet, the World Wide Web, and social media. The term "social media" includes blogs and microblogs, social networking sites, and picture and video sharing sites, such as Twitter, Facebook, LinkedIn, Flickr, and YouTube.

Social communications should be used in a manner consistent with Catholic values and principles of the Order. Members who use social communications should carefully review and at all times observe the Order's Social Communications Guidelines and Policy, which can be found under the Social Communications tab on the Officer's Desk Reference located in the Officer's Online at <u>www.kofc.org</u>. The Guidelines and Policy apply to members and subordinate units of the Order when they choose to identify themselves as members of the Knights of Columbus or to discuss the work of the Knights of Columbus using social communications. Members should be aware that the Laws and official policies of the Knights of Columbus apply to fraternal social communications as they would in any other setting. The reputation of the Order depends upon how members conduct themselves, both online

and in person. Accordingly, members using social communications should remember that they are expected to conduct themselves as Catholic gentlemen, which at a minimum requires that any material posted online respect human dignity and maintains a culture of respectful dialogue and friendship. Correspondence should be addressed to the individual, using his full, proper name (not his nickname), followed by his proper title, whether he be a Knight of Columbus, a Priest or a businessperson. If an individual has more than one title, the highest ranking title is always used. Names of civic and religious individuals are prefixed by such forms as His Excellency, The Honorable, Reverend Father, etc. Prefix titles of Mr., and Mrs. or Ms. Are omitted when the individual has another official title. If he has no title, Mr., Mrs., or Ms. Should always be used as a prefix to his or her name. When addressing an individual as an official of an organization, the name of the

organization should always be shown on the next line. In the event that you have a close working relationship with any officer, your letter need not be so formal. However you first must acknowledge the office he holds. The salutation would then be "Worthy Grand Knight and dear Brother Bill." The individual's full proper name and title are always shown on both the letter and the envelope.
